DOCUMENT REQUIREMENTS

STICKER VISA

A. General Documents (All Applicants)

□ Fully completed Visa Application Form (DHA-84) in black ink
□ Two (2) identical passport photographs (35mm × 45mm, white background)
□ Valid international passport (at least 30 days beyond return date)
□ Copy of passport bio-data page and all previous visas
□ Typed self-introduction letter (with address and phone number)
□ Introduction/recommendation letter from employer (signed with company
stamp)
□ Proof of accommodation – direct hotel confirmation (not third-party
websites)
□ Yellow fever vaccination certificate (for adults) or immunisation card (for
minors)
□ Proof of financial status – six (6) months recent bank statement (original,
stamped & signed)
□ Flight booking/reservation (verifiable)

B. Supporting Documents (Depending on Category)

If Visiting Friends or Family
□ Invitation letter from host in South Africa (signed, with address and phone
number)
□ Proof of residence of host (utility bill or lease)
□ Certified ID copy of host (if South African) or passport & valid permit (if
foreigner)
□ Three (3) months bank statement of host (stamped and signed)
If Travelling for Business
🗆 Letter of invitation from South African company (with contact details &
physical address)
□ Conference/training confirmation (if applicable)
□ Certified South African ID copy of company representative
If Travelling for Medical Treatment (Less than 90 Days)
□ Referral letter from a Nigerian doctor stating reason for referral
□ Letter from South African medical institution confirming:
– Availability of space
– Estimated cost of treatment
– Nature and duration of treatment
□ Proof of person/institution responsible for medical expenses
□ Proof of sufficient funds to cover all medical and incidental costs
If Applicant is a Minor (Under 18) Certified birth certificate
□ Notarized parental consent letter(s) (if travelling without one or both
parents)
□ Copy of parents' ID cards/passports

C. Submission Notes

All applications must be typed or written in block letters

All bank statements must be original, stamped, and signed by the bank authority

Payment is accepted only via POS — no cash

For group/family applications, each applicant must submit separate document sets.

Ensure all photocopies are clear and in color.

E-VISA DOCUMENT REQUIREMENTS

- 2. Flight reservation and yellow fever card
- 3. Three (3) months bank statement (with a letter of authorization from the bank confirming the account is valid)
- 4. Hotel reservation(s)
- 5. Passport pages showing previous visas and stamps
- 6. Self-introduction letter
- 7. Introduction letter from the place of work.
